Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, We wish to inform that the Hon'ble High Court of Delhi, vide order which was published on the website of Hon'ble High Court on 15th May ,2025 has allowed the writ petition filed by the Company in the year 2019. The Court has directed the Department of Fertilizers, Ministry of Chemicals and Fertilizers, Government of India, to release the subsidy amount of ₹53.50 crores (Rupees Fifty-Three Crores and Fifty Lakhs only) to the Company under the Nutrient Based Subsidy (NBS) Scheme, within six weeks. The said subsidy pertains to a consignment of imported Di-Ammonium Phosphate (DAP) fertilizer supplied to various states in 2013. The order is expected to have a positive impact on the Company's financials.

The details as required under Regulation 30 of Listing Regulations and the Circulars issued thereunder is enclosed herewith as Annexure 1.

The denial was based on a laboratory test report classifying an imported consignment of Di-Ammonium Phosphate (DAP) fertilizer as non-standard. The Company contended that the consignment was certified as standard by the State Governments of Uttar Pradesh, Madhya Pradesh, and Punjab and that the rejection was contrary to the applicable policy framework and ICAR's scientific findings.
