Role Scope: Responsible for Rake supervision, Inventory control, co-ordination with field staff, Vendor management.

Job Elements:

- Preparation of monthly dispatch plan and submitting to RM
- Identification & selection of warehouse, Warehouse Management-Space utilization, Accounting.
- Initiating note for space reservation in consultation with RM (M).
- Arranging for inter Warehouse movement (on emergency basis) after obtaining approval from S&D (CO)
- Supervision of Rake handling and dispersal of material to maximum possible extent.
- Collection of Rake Handling Reports from FSOs.
- Obtaining Monthly stock reports from all Field Officers duly certified by them.
- Monthly product wise stocks and empty bags reconciliation.
- Submission of stock reconciliation To Regional Accounts.
- Sending documents & data required for subsidy claim to Regional Accounts & Asset / Subsidy Cell.
- Forwarding of monthly / periodical reports to CO-S&D.
- Collection of Security Deposits from the Warehouse/H&T operators.
- Verification of storage, H&T, standardization and transportation bills and parking of bills in SAP.
- Updating of Road distances of new destinations and periodical verification of distances.

1. SAP transactions -

- a) Checking on daily basis the data flow in SAP & Sale Portal
- b) Submission of templates for creation of new routes, cost masters, plants, vendors
- Secondary Freight Optimization based on L1/L2/L3, RH Vs WH Movement Ratio, Monthly dispatch plan & distributing Planning-(Rail/Road) in co ordination with Regional Head.
- Vendor Management-Survey for appointment of new H&T contractors/renewal of existing contracts, Performance evaluation of H&T and storage contractors(Twice in year-half yearly).
- Supervising standardization of stocks and PLR accounting, Empty bag accounting-Arranging 'A' class bags and disposal of 'C' class bags.
- Physical verification and ATR, Rake Report, JIR, MIS, Stock reports& Reconciliation Adherence to Co standard and controlling under recovery.
- Registration of all WHs in FRC, SAP Transaction: for creation of new route, cost masters, plants, vendors.
- Learning initiatives-Attending Training & Sharing information policies with field force.
